COOPERATIVE BUSINESS SERVICES, LLC <u>GENERAL PRIVACY POLICY</u>

This General Privacy Policy (this "General Policy") explains what information Cooperative Business Services, LLC (the "Company") collects through its website, <u>www.cbscuso.com</u> (the "Website"), including the mobile version, why that information is collected, and how it is used. Information may be provided to Company's subsidiaries and affiliates without Your consent. Information gathered by the Company will be solely used for Company's purpose as a credit union servicing organization and will not be used for any unlawful purpose or subject to further unauthorized disclosure.

3. <u>Cookies</u>. Company may utilize "cookies" and server logs to collect information about how the Company's Website is used. Cookies are small files that websites save to your hard disk or to your browser's memory. Information gathered through cookies and server logs may include the date and time of visits, the pages viewed, the time spent on the Website, and the websites visited just before and just after visiting the Website. Most Internet browsers automatically accept cookies, but you can usually modify your browser settings to decline cookies or to notify you when a cookie is being placed

on your computer. If you choose not to accept cookies, you may not be able to experience all of the features of the Website.

4. <u>Security</u>. Company uses commercially reasonable methods to ensure the security of the information You provide to us and the information that is automatically collected. This includes using standard security protocols and working with reputable third-party vendors. Electronic mail (email) is not recognized as a secure medium of communication. For this reason, we request that You do not send sensitive information to us by email. If You do, it is at Your own risk.

5. <u>Changes to Policy</u>. Company may, in its own discretion and from time to time, change, update or modify this Policy. When Company does, it will date the revised Policy. You should revisit this page periodically to become aware of the most recent privacy terms; Your use of the Website after such changes have been posted constitute Your agreement to such changes.
